- d. Use the abbreviations as Ar., Ir. and Sr.
- e. Selling or supplying (i.e. rendering services for payment or reward) of any architectural plan, drawing, tracing or the like that is to be used in the construction/enlargement/alteration of any building or parts of a building; or
- f. Consultancy or advisory services for professional engineering works which includes any service, consultation, investigation, evaluation, planning, design, or responsible supervision of construction or operation in connection with any public or privately owned public utilities, buildings, machines, equipment, processes, works or projects wherein the public interest and welfare, or the safeguarding of life, public health or property is concerned or involved, and that requires the application of professional engineering principles and data; or
- g. Quantity surveying works included preparation of any cost feasibility study reports, preliminary estimates, cost plans, documents and reports for pre-qualification of contractors, bills of quantities and other tender documents, tender estimates and reports, contract documents and valuations of works for interim payments, variation and final accounts for construction projects in Brunei Darussalam,
